The text shall be typed on A4 size (white copy paper), margins: left 3 cm, others 2.5 cm,

Times New Roman font type, size 12.

Please do not insert page numbers. No line(s) feed between paragraphs, the text shall be continuous.

Headings (chapter titles) shall be in capitals, with a blank line preceding and following them.

Within chapters, subheadings shall be italicized with a blank line preceding and following them.

Only black and white images shall be published in the conference volume.

References in the text shall be numbered automatically, as footnotes.

The recommended form of the list of references at the end of the paper:

The paper shall be written in English, French or German.

II. CONFERENCE PROCEEDINGS AND PUBLICATION OF THE CONFERENCE VOLUME

Conference Sections - Public Law and Private Law

The paper presentations shall take place in the Conference Halls of the Faculty of Law and Administrative Sciences, where video projectors are available as well as the equipment for simultaneous translation in English.

In each section, the time allotted to the oral presentations shall be 15 minutes.

The texts of the presented papers (max. 15 pages, size A4) shall be published in the conference volume, provided that the suggested electronic form of the paper is sent to the faculty e-mail address (drept@drept.uvt.ro) and the registration fee is paid by 06.03.2011.

The conference volume shall be given to the participants. Those who do not attend the conference shall receive the volume by regular mail.

III. REQUIREMENTS FOR PARTICIPATION

Participation fees:

Each participant can present a maximum of 2 papers.

The registration fee of 100 EUR covers the publication costs of only one paper, including papers written by co-authors.

The publication of the second paper entails an additional cost of 30 EUR.

For the participants who also choose accommodation, the organizers shall book rooms at one of the 3-star hotels in Timişoara (35 EUR single/ 45 EUR double).
